**DEFENDANT MIDJOURNEY, INC.'S
ANSWER TO COMPLAINT**

REQUEST FOR A JURY TRIAL

Date Action Filed: June 11, 2025

1 Defendant Midjourney, Inc. (“Midjourney”), by and through counsel, hereby
2 responds to the Complaint (“Complaint”) filed by Plaintiffs Disney Enterprises, Inc.,
3 Marvel Characters, Inc., MVL Film Finance LLC, Lucasfilm LTD. LLC, Twentieth
4 Century Fox Film Corporation, Universal City Studios Productions LLLP, and
5 Dreamworks Animation L.L.C. (together, “Plaintiffs”). Unless specifically admitted,
6 Midjourney denies each of the allegations in the Complaint.¹

7 **PRELIMINARY STATEMENT**

8 Founded in 2022, Midjourney is an artificial intelligence (“AI”) research lab
9 dedicated to creating tools that augment and expand the human imagination. Its
10 namesake generative AI platform does just that, empowering tens of millions of users—
11 *including Plaintiffs*—to express themselves in ways that otherwise would not have been
12 possible. For many, Midjourney has become an essential tool for bringing their ideas to
13 life, with users’ images having won awards, adorned magazine covers, appeared in
14 national ads, and served as the bases for set designs in an Oscar winning film.

15 The AI technology that powers Midjourney is a type of neural network designed
16 to produce original images in response to user instructions (“prompts”). To develop this
17 capability, Midjourney’s AI models had to be trained on billions of publicly available
18 images, which are paired with text descriptions, in order to learn visual concepts and
19 how they correspond to language. During training, complex statistical relationships
20 between visual features and words in the text-image pairs are encoded within the model,
21 enabling it to understand and accurately respond to user prompts.

22 This process is akin to how humans learn to draw or paint—not by memorizing
23 individual artworks, but by internalizing patterns and techniques through repeated
24 exposure and practice. Similarly, Midjourney’s models form a generalized
25 understanding of visual styles, objects, and compositions based on statistical
26 regularities in training data. When a user enters a prompt, the model doesn’t retrieve

1 an image from storage; rather, a new image is synthesized from scratch, guided by user
2 instruction and the statistical patterns encoded within its artificial neurons.

3 Plaintiffs, collectively representing two of the largest traditional media
4 companies in the world, have benefitted from and continue to benefit from
5 Midjourney and other, similar generative AI tools. Indeed, many dozens of
6 Midjourney subscribers are associated with Plaintiffs' corporate email addresses, and
7 Midjourney is also a popular tool among the visual effects companies and other
8 vendors employed by Plaintiffs. As Bob Iger, Disney's CEO, recently exclaimed
9 during a discussion about his company's utilization of AI, "technology is an
10 invaluable tool for artists," and generative AI is no different.

11 Years after its launch, Plaintiffs now take aim at Midjourney in two ways.
12 First, they allege that the process of training an AI model on billions of images
13 violates their rights, even though only a small fraction of those images may contain
14 individual frames from Plaintiffs' films and shows. As a matter of equity, Plaintiffs
15 cannot have it both ways, seeking to profit—through their use of Midjourney and
16 other generative AI tools—from industry-standard AI training practices on the one
17 hand, while on the other hand accusing Midjourney of wrongdoing for the same. But
18 Plaintiffs are also wrong on the merits. Copyright law does not confer absolute
19 control over the use of copyrighted works. The limited monopoly granted by
20 copyright must give way to fair use, which safeguards countervailing public interests
21 in the free flow of ideas and information. Training a generative AI model to
22 understand concepts by extracting statistical information embedded in copyrighted
23 works is a quintessentially transformative fair use – a determination resoundingly
24 supported by courts that have considered the issue. *See Kadrey v. Meta Platforms,*
25 *Inc.*, 2025 WL 1752484, at *12 (N.D. Cal. June 25, 2025) (describing training as
26 "highly transformative"); *Bartz v. Anthropic PBC*, 2025 WL 1741691, at *7 (N.D.
27 Cal. June 23, 2025) (calling training "spectacularly" transformative).

28 Second, Plaintiffs complain that *Midjourney* has created and displayed images

1 that incorporate characters from popular film and television series, that these images
2 are *per se* infringing, and that Midjourney is liable for their creation. But Plaintiffs’
3 framing is premised on mischaracterizations of how Midjourney works and its role
4 in the creative process. The Midjourney platform is an instrument for *user*
5 expression. It assists with the creation of images only at the direction of its users,
6 guided by their instructions, in what is often an elaborate and time-consuming
7 process of experimentation, iteration, and discovery.

8 And while Midjourney users are required by Midjourney’s Terms of Service
9 to refrain from infringing the intellectual property rights of others, including
10 Plaintiffs’ rights, Midjourney does not presuppose and cannot know whether any
11 particular image is infringing absent notice from a copyright owner and information
12 regarding how the image is used. Indeed, there are any number of legitimate, non-
13 infringing grounds to create images incorporating characters from popular culture
14 like those claimed by Plaintiffs, including non-commercial fan art, experimentation
15 and ideation, and social commentary and criticism. Plaintiffs seek to stifle them all.

16 Plaintiffs could have—and should have—followed Midjourney’s Digital
17 Millennium Copyright Act notice and takedown procedure, codified in its Terms of
18 Service, by identifying the specific images they believe are infringing and providing
19 the URLs where they are displayed. Doing so would have afforded any accused
20 Midjourney users the opportunity to respond. Instead, Plaintiffs made sweeping
21 allegations about Midjourney writ large, commenced this litigation, and are pursuing
22 a path that chills lawful expression.

23 In the end, this case is not about Midjourney profiteering off of what Plaintiffs
24 call “infringement.” Midjourney isn’t. Nor is it about any purported “harm” to
25 Plaintiffs; they have identified none. Rather, this case is about whether Plaintiffs’
26 alleged copyrights entitle them to prohibit the use of their works to train generative
27 AI models, and to prevent the incorporation of elements of those works within the
28 creations of generative AI users, regardless of the contents of those creations and the

1 ultimate ends to which users put them. Plaintiffs are not so entitled. Copyright has
2 “always been closely connected with freedom of expression, on the one hand, and []
3 technological improvements in means of dissemination, on the other,” with the law
4 recognizing that limited use of copyrighted material to create new technologies and
5 mediums advances copyright’s ultimate objective: the stimulation of creative
6 expression for public benefit. *Sony Corp. of Am. v. Universal City Studios, Inc.*, 464
7 U.S. 417, 431 fn. 12 (1984) (quotation omitted). As Midjourney will establish,
8 Plaintiffs’ overreach rests on fundamental misunderstandings of generative AI, its
9 role in user creation, and the principles underpinning copyright law.

10 As set forth below, Midjourney responds to the Complaint’s specific
11 allegations.

12 **INTRODUCTION**

13 1. Disney and Universal are two industry behemoths who compete with
14 one another in the motion picture industry. To be sure, they have released a number
15 of popular motion pictures featuring various fictional characters. Midjourney denies
16 that it seeks to reap the rewards of Plaintiffs’ creative investment. Midjourney also
17 denies Plaintiffs’ characterization of Midjourney as a virtual vending machine for
18 unauthorized copies of Plaintiffs’ works. Midjourney lacks knowledge and
19 information sufficient to form a belief as to the truth of the remaining allegations set
20 forth in paragraph 1, and on that basis denies the same.

21 2. Midjourney denies the allegations and characterizations in paragraph 2.

22 3. Midjourney admits that Plaintiffs sent letters to Midjourney in which
23 they made certain demands of Midjourney. Midjourney further admits that it has
24 millions of subscribers. Midjourney denies the remaining allegations in paragraph 3.

25 4. Midjourney lacks knowledge and information sufficient to form a belief
26 as to the truth of whether and which Plaintiff allegedly owns copyrights in the
27 asserted works, as well as the extent to which videos created by Midjourney users
28 will incorporate elements of those works. Midjourney denies the remaining

1 allegations and characterizations in paragraph 4.

2 5. Midjourney lacks knowledge and information sufficient to form a belief
3 as to the truth of the allegations set forth in paragraph 5, and on that basis denies the
4 same.

5 6. Midjourney lacks knowledge and information sufficient to form a belief
6 as to the truth of the allegations set forth in paragraph 6, and on that basis denies the
7 same.

8 7. Midjourney lacks knowledge and information sufficient to form a belief
9 as to the truth of the allegations set forth in paragraph 7, and on that basis denies the
10 same.

11 8. Midjourney denies Plaintiffs' characterization of U.S. copyright law.
12 Midjourney also denies that its business "was developed using" Plaintiffs' works or
13 otherwise concerns Plaintiffs' works. Midjourney further denies Plaintiffs'
14 characterization of how images are generated by users of Midjourney. Midjourney
15 lacks knowledge and information sufficient to form a belief as to the truth of the
16 remaining allegations set forth in paragraph 8, and on that basis denies the same.

17 9. Midjourney denies the allegations in paragraph 9. Midjourney also
18 observes that the Complaint does not provide any examples of the alleged marketing
19 or promotion or the alleged false implications.

20 10. Midjourney admits that it has implemented content moderation policies
21 that limit users' ability to generate images that incorporate violence and/or nudity.
22 Midjourney has also adopted Terms of Service that govern how users may utilize the
23 Midjourney platform. Midjourney lacks knowledge and information sufficient to
24 form a belief regarding the content moderation policies of "other" generative AI
25 services alleged in this paragraph, and on that basis denies the same. Except as
26 expressly admitted, Midjourney denies the allegations set forth in paragraph 10.

27 11. Midjourney admits that, prior to filing this lawsuit, Plaintiffs sent
28 demand letters to Midjourney, which are attached to the Complaint as Exhibits C and

1 D and speak for themselves. To the extent the allegations set forth in this paragraph
2 purport to summarize or characterize the contents of the article located at
3 [https://generativeai.pub/midjourney-finally-releases-v7-image-model-](https://generativeai.pub/midjourney-finally-releases-v7-image-model-e07455e60f57)
4 [e07455e60f57](https://generativeai.pub/midjourney-finally-releases-v7-image-model-e07455e60f57), the article speaks for itself. Except as expressly admitted,
5 Midjourney denies the allegations set forth in paragraph 11.

6 12. Midjourney denies the characterizations in this paragraph. Midjourney
7 lacks knowledge and information sufficient to form a belief as to the truth of the
8 allegations that the American motion picture industry has created millions of jobs
9 and contributed more than \$260 billion to the U.S. economy. Midjourney denies the
10 remaining allegations and characterizations in paragraph 12.

11 13. The extent to which this case presents a “close call” under established
12 precedent is a legal conclusion to which no response is required. Midjourney
13 otherwise denies the remaining allegations and characterizations in paragraph 13.

14 14. Midjourney denies the allegations and characterizations in paragraph
15 14.

16 **THE PARTIES**

17 15. Midjourney lacks knowledge and information sufficient to form a belief
18 as to the truth of the allegations set forth in paragraph 15, and on that basis denies the
19 same.

20 16. Midjourney lacks knowledge and information sufficient to form a belief
21 as to the truth of the allegations set forth in paragraph 16, and on that basis denies the
22 same.

23 17. Midjourney lacks knowledge and information sufficient to form a belief
24 as to the truth of the allegations set forth in paragraph 17, and on that basis denies the
25 same.

26 18. Midjourney lacks knowledge and information sufficient to form a belief
27 as to the truth of the allegations set forth in paragraph 18, and on that basis denies the
28 same.

1 19. Midjourney lacks knowledge and information sufficient to form a belief
2 as to the truth of the allegations set forth in paragraph 19, and on that basis denies the
3 same.

4 20. Midjourney lacks knowledge and information sufficient to form a belief
5 as to the truth of the allegations set forth in paragraph 20, and on that basis denies the
6 same.

7 21. Midjourney lacks knowledge and information sufficient to form a belief
8 as to the truth of the allegations set forth in paragraph 21, and on that basis denies the
9 same.

10 22. Midjourney lacks knowledge and information sufficient to form a belief
11 as to the truth of the allegations set forth in paragraph 22, and on that basis denies the
12 same.

13 23. Midjourney lacks knowledge and information sufficient to form a belief
14 as to the truth of the allegations set forth in paragraph 23, and on that basis denies the
15 same.

16 24. Midjourney lacks knowledge and information sufficient to form a belief
17 as to the truth of the allegations set forth in paragraph 24, and on that basis denies the
18 same.

19 25. Midjourney admits that, by the phrasing of the Complaint, the phrases
20 “Copyrighted Works” and “Plaintiffs’ Copyrighted Works,” refer, collectively, to the
21 alleged works asserted by the Plaintiffs and listed in Exhibits A and B to the
22 Complaint. Midjourney lacks knowledge and information sufficient to form a belief
23 as to the truth of the remaining allegations set forth in paragraph 25, and on that basis
24 denies the same.

25 26. Midjourney admits the allegations in paragraph 26.

26 **JURISDICTION AND VENUE**

27 27. The allegations in this paragraph state a legal conclusion to which no
28 response is required. To the extent a response is deemed required, Midjourney admits

1 that this action purports to arise under the copyright laws of the United States, 17
2 U.S.C. § 101 *et seq.*, and that the Court has original subject matter jurisdiction over
3 this action pursuant to 28 U.S.C. §§ 1331, 1338(a), provided that standing and other
4 requirements are met. Except as expressly admitted, Midjourney denies the
5 allegations set forth in paragraph 27.

6 28. The allegations in this paragraph state a legal conclusion to which no
7 response is required. To the extent a response is deemed to be required, Midjourney
8 admits that this Court has personal jurisdiction over it with respect to the instant
9 action. Except as expressly admitted, Midjourney denies the allegations in paragraph
10 28.

11 29. Midjourney denies the allegations and characterizations in paragraph
12 29.

13 30. The allegations in this paragraph state a legal conclusion to which no
14 response is required. To the extent a response is deemed to be required, Midjourney
15 admits that venue is proper in this Court with respect to the instant action. Except as
16 expressly admitted, Midjourney denies the allegations in paragraph 30.

17 31. The allegations in this paragraph state a legal conclusion to which no
18 response is required. To the extent a response is deemed to be required, Midjourney
19 admits that venue is proper in this Court with respect to the instant action. However,
20 Midjourney denies that it purposefully directed its activities toward this District or
21 that venue is proper under 28 U.S.C. § 1400(a).

- 22 a. Midjourney denies the allegations in paragraph 31(a).
- 23 b. Midjourney denies the allegations in paragraph 31(b).
- 24 c. Midjourney denies the allegations in paragraph 31(c).
- 25 d. Midjourney admits that some Midjourney subscribers are located
26 in this District, that those users must engage with the same sign-up flow as every
27 other user, and that Midjourney has accepted payment for subscriptions from users
28 located in this District. Midjourney denies the remaining allegations in paragraph

1 31(d).

2 e. Midjourney admits that it has at least one employee who resides
3 in Los Angeles, California, which is in this District. Midjourney denies the remaining
4 allegations in paragraph 31(e).

5 f. Midjourney admits that Midjourney CEO, David Holz, is quoted
6 in a Forbes interview making the statements excerpted in paragraph 31. Midjourney
7 further admits that it promotes its services to professionals in the creative industries,
8 and that many creatives working for and on behalf of Plaintiffs are or have been
9 Midjourney subscribers. To the extent the allegations set forth in this paragraph
10 purport to summarize or characterize the contents of the article located at
11 [https://www.forbes.com/sites/robsalkowitz/2022/09/16/midjourney-founder-david-](https://www.forbes.com/sites/robsalkowitz/2022/09/16/midjourney-founder-david-holz-on-the-impact-of-ai-on-art-imagination-and-the-creative-economy/)
12 [holz-on-the-impact-of-ai-on-art-imagination-and-the-creative-economy/](https://www.forbes.com/sites/robsalkowitz/2022/09/16/midjourney-founder-david-holz-on-the-impact-of-ai-on-art-imagination-and-the-creative-economy/), such
13 article speaks for itself. Midjourney lacks knowledge and information sufficient to
14 form a belief as to the truth of the remaining allegations in paragraph 31(f), and on
15 that basis denies the same.

16 32. Midjourney denies the allegations in paragraph 32.

17 **FACTUAL ALLEGATIONS**

18 33. Midjourney lacks knowledge and information sufficient to form a belief
19 as to the truth of the allegations in paragraph 33, and on that basis denies the same.

20 34. Midjourney lacks knowledge and information sufficient to form a belief
21 as to the truth of the allegations in paragraph 34, and on that basis denies the same.

22 35. Midjourney lacks knowledge and information sufficient to form a belief
23 as to the truth of the allegations in paragraph 35, and on that basis denies the same.

24 36. Midjourney admits that the original Star Wars film, Episode IV: A New
25 Hope, was released in 1977, and that Star Wars has been the subject of various
26 audiovisual series, theme park attractions, and merchandise. Midjourney lacks
27 knowledge and information sufficient to form a belief as to the truth of the allegations
28 in paragraph 36, and on that basis denies the same.

1 37. Midjourney lacks knowledge and information sufficient to form a belief
2 as to the truth of the allegations in paragraph 37, and on that basis denies the same.

3 38. Midjourney admits that Darth Vader, Yoda, Storm Troopers, and Clone
4 Troopers are characters or character-types in Star Wars and that they possess at least
5 some of the visual and narrative characteristics attributed to them in paragraph 38.
6 Midjourney lacks knowledge and information sufficient to form a belief as to the
7 truth of the remaining allegations in paragraph 38, and on that basis denies the same.

8 39. Midjourney admits that R2-D2, C-3PO, and Chewbacca are characters
9 in Star Wars. Midjourney lacks knowledge and information sufficient to form a
10 belief as to the truth of the allegations in paragraph 39, and on that basis denies the
11 same.

12 40. Midjourney lacks knowledge and information sufficient to form a belief
13 as to the truth of the allegations in paragraph 40, and on that basis denies the same.

14 41. Midjourney lacks knowledge and information sufficient to form a belief
15 as to the truth of the allegations in paragraph 41, and on that basis denies the same.

16 42. Midjourney lacks knowledge and information sufficient to form a belief
17 as to the truth of the allegations in paragraph 42, and on that basis denies the same.

18 43. Midjourney admits that there are numerous superheroes and other
19 characters in Marvel brand comics and derivations thereof. Midjourney further
20 admits that Iron Man is a superhero character depicted in certain Marvel brand
21 comics and films and derivations thereof, and that the character possesses at least
22 some of the visual and narrative characteristics attributed to him in paragraph 43.
23 Midjourney lacks knowledge and information sufficient to form a belief as to the
24 truth of the remaining allegations in paragraph 43, and on that basis denies the same.

25 44. Midjourney further admits that the Hulk is a superhero character
26 depicted in certain Marvel brand comics and films and derivations thereof, and that
27 the character possesses at least some of the visual and narrative characteristics
28 attributed to him in paragraph 44. Midjourney lacks knowledge and information

1 sufficient to form a belief as to the truth of the remaining allegations in paragraph 44,
2 and on that basis denies the same.

3 45. Midjourney further admits that Spider-Man is a superhero character
4 depicted in certain Marvel brand comics and films and derivations thereof, and that
5 the character possesses at least some of the visual and narrative characteristics
6 attributed to him in paragraph 45. Midjourney lacks knowledge and information
7 sufficient to form a belief as to the truth of the remaining allegations in paragraph 45,
8 and on that basis denies the same

9 46. Midjourney admits that Marvel brand comics and films, and derivations
10 thereof, have featured the characters Deadpool, Groot, Wolverine, and Captain
11 America. Midjourney lacks knowledge and information sufficient to form a belief
12 as to the truth of the remaining allegations in paragraph 46, and on that basis denies
13 the same

14 47. Midjourney lacks knowledge and information sufficient to form a belief
15 as to the truth of the allegations in paragraph 47, and on that basis denies the same.

16 48. Midjourney admits that Homer, Marge, Bart, Lisa, and Maggie are
17 characters in the Simpsons series, and that these characters possess at least some of
18 the visual and narrative characteristics attributed to them in paragraph 48.
19 Midjourney lacks knowledge and information sufficient to form a belief as to the
20 truth of the remaining allegations in paragraph 48, and on that basis denies the same.

21 49. Midjourney lacks knowledge and information sufficient to form a belief
22 as to the truth of the allegations in paragraph 49, and on that basis denies the same.

23 50. Midjourney lacks knowledge and information sufficient to form a belief
24 as to the truth of the allegations in paragraph 50, and on that basis denies the same.

25 51. Midjourney lacks knowledge and information sufficient to form a belief
26 as to the truth of the allegations in paragraph 51, and on that basis denies the same.

27 52. Midjourney admits that Buzz Lightyear and Lightning McQueen are
28 characters in, respectively, Toy Story and Cars, and that these characters possess at

1 least some of the visual and narrative characteristics attributed to them in paragraph
2 52. Midjourney lacks knowledge and information sufficient to form a belief as to the
3 truth of the remaining allegations in paragraph 52, and on that basis denies the same.

4 53. Midjourney lacks knowledge and information sufficient to form a belief
5 as to the truth of the allegations in paragraph 53, and on that basis denies the same.

6 54. Midjourney lacks knowledge and information sufficient to form a belief
7 as to the truth of the allegations in paragraph 54, and on that basis denies the same.

8 55. Midjourney admits that, since the release of *Snow White*, animated films
9 titled *Peter Pan*, *The Little Mermaid*, *The Lion King*, *Frozen*, and *Mulan* have been
10 released under the Disney brand. Midjourney lacks knowledge and information
11 sufficient to form a belief as to the truth of the remaining allegations in paragraph 55,
12 and on that basis denies the same.

13 56. Midjourney admits that the film *Frozen* features the characters Elsa and
14 Olaf, *The Little Mermaid* features the character Ariel, the film *Aladdin* features the
15 characters Jasmine and Aladdin, the film *Mulan* features the character Mulan, the
16 film *Lilo and Stich* features the characters Lilo and Stitch, and the film *Snow White*
17 features the character Snow White. Midjourney lacks knowledge and information
18 sufficient to form a belief as to the truth of the remaining allegations in paragraph 56,
19 and on that basis denies the same.

20 57. Midjourney admits that Elsa and Stitch are characters in, respectively,
21 *Frozen* and *Lilo and Stich*, and that these characters possess at least some of the
22 visual and narrative characteristics attributed to them in paragraph 57. Midjourney
23 lacks knowledge and information sufficient to form a belief as to the truth of the
24 remaining allegations in paragraph 57, and on that basis denies the same.

25 58. Midjourney lacks knowledge and information sufficient to form a belief
26 as to the truth of the allegations in paragraph 58, and on that basis denies the same.

27 59. Midjourney lacks knowledge and information sufficient to form a belief
28 as to the truth of the allegations in paragraph 59, and on that basis denies the same.

1 60. Midjourney admits that Minions are creatures featured in the Despicable
2 Me film series and spin-offs of the same, and that they possess at least some of the
3 narrative characteristics attributed to them in paragraph 60. Midjourney lacks
4 knowledge and information sufficient to form a belief as to the truth of the remaining
5 allegations in paragraph 60, and on that basis denies the same.

6 61. Midjourney lacks knowledge and information sufficient to form a belief
7 as to the truth of the allegations in paragraph 61, and on that basis denies the same.

8 62. Midjourney lacks knowledge and information sufficient to form a belief
9 as to the truth of the allegations in paragraph 62, and on that basis denies the same.

10 63. Midjourney lacks knowledge and information sufficient to form a belief
11 as to the truth of the allegations in paragraph 63, and on that basis denies the same.

12 64. Midjourney lacks knowledge and information sufficient to form a belief
13 as to the truth of the allegations in paragraph 64, and on that basis denies the same.

14 65. Midjourney admits that the Shrek is a character in *Shrek*, and that he

18 information and belief, Plaintiffs are, like Midjourney, directly or indirectly engaged
19 in training generative AI models on publicly available works, some of which are
20 protected by copyrights owned by third parties. Accordingly, it would be inequitable
21 to permit Plaintiffs to benefit from the development and use of generative AI tools,
22 including Midjourney, on the one hand, and, on the other hand, prevent the
23 development and use of Midjourney by others.

24 **SIXTH AFFIRMATIVE DEFENSE**

25 Plaintiffs' claims are barred, in whole or in part, to the extent that any
26 purported copying of Plaintiffs' protectable expression is *de minimis*.

27 **SEVENTH AFFIRMATIVE DEFENSE**

28 Plaintiffs' claims are barred, in whole or in part, on the grounds that (i)

1 Plaintiffs have not provided Midjourney with adequate notice of specific instances
2 of purported copyright infringement by Midjourney users; and (ii) Midjourney is
3 entitled to avail itself to the infringement safe harbors codified in 17 U.S.C. § 512.
4 As alleged above, Plaintiffs have not complied with the provisions of the DMCA.

5
6 **PRAYER FOR RELIEF**

7 WHEREFORE, Midjourney asks this Court to enter judgment:

- 8 1. Dismissing the Complaint with prejudice;
- 9 2. Finding that Plaintiffs are not entitled to the relief requested in the
10 Complaint, or to any relief whatsoever, including for direct, contributory, or vicarious
11 copyright infringement;
- 12 3. Finding that one or more of the copyrights asserted by Plaintiffs are
13 unenforceable and/or that Plaintiffs' claims have been limited, barred, or discharged
14 by reason of the affirmative and additional defense(s) set forth herein;
- 15 4. Awarding reasonable attorneys' fees and all other recoverable expenses
16 to Midjourney;
- 17 5. Awarding Midjourney its costs; and,
- 18 6. Granting such other and further relief as may be just and proper.
