Noise Action Plan Update

London Luton Airport's Noise Action Plan which covers the period 2019-2023, was submitted to the Department for Environment Food and Rural Affairs (DEFRA) in September. The Noise Action Plan sets out how we plan to manage and reduce the impact of aircraft noise to the local communities over the next 5 years.

The Noise Action Plan concentrates on five separate areas for action, including operational procedures and restrictions, the use of quieter aircraft, mitigation and working with communities and industry stakeholders.



As part of the process we completed two consultations during which members of the Airport's Consultative Committee provided feedback on the plan. If approved, the Noise Action Plan will be effective as of the 1st January 2019.

An aircraft is considered to comply with departure procedures if it remains within the Noise Preferential Route corridors, up to an altitude of 3,000ft during the day or 4,000ft during the night. On our RNAV route (26 Match/Detling), aircraft must remain within the corridor until an altitude of 4,000ft day and night.

A Continuous Descent Approach (CDA) is conducted by an aircraft on arrival. As an aircraft descends from 5,000ft, there should be no period of level flight longer than 2.5 nautical miles. This keeps the aircraft higher for longer and reduces the noise disturbance at ground level.

Airspace Policy and Guidance

Between July and September of this year the CAA completed a consultation period on a draft airspace modernisation strategy (CAP1690). The finalised Airspace Modernisation Strategy will be published at the end of the year.

The draft Airspace Modernisation Strategy forms part of the Government's new arrangements to take forward the delivery of the airspace modernisation programme. The strategy sets out the ends, ways and means of modernising airspace.

The Department for Transport (DFT) has also recently announced that we will be expecting a new Aviation Strategy Green Paper to be published in December 2018. This Green Paper will likely set out the evolution of the aviation policy for the United Kingdom.

Luton Airport Supporting Macmillan

Staff at LLA raised more than £2,500 for Macmillan Cancer Support, in September.
