### **Notice of EU RoHS Directive on Servomotor**

We would like to express our sincere gratitude for your continued patronage of our Mitsubishi Electric Servomotor.

Recently, it was found that the load-side bracket used for the servo motors exceeded the permissible limit value of a certain phthalate ester (DEHP) restricted by the EU RoHS directive.

There is no impact on the quality, function or performance of the product, nor on the environment or health, and there is no problem with its continued use.

However, if you plan to deliver equipment incorporating the target product to Europe, or if you have already delivered the target product to Europe, there are precautions. See below for details.

If you plan to deliver equipment incorporating the target products to Europe, please consult our branch office or the distributor.


## 3.2 Products delivered to Europe
