BKV GMBH minimizes data collection and, whenever possible, processes data locally on your device. We do not store unnecessary user data or track activity without your explicit consent. Personal data is shared with third parties only when necessary for service provision or required by law.

3. Information We Collect

3.1 Device & Usage Data

- Device Information: Model, operating system version, unique device identifier (IDFV/IDFA).
- Usage Data: App launch times, screen views, feature toggles used.

3.2 No User Registration

No accounts, emails, or passwords are required to use the App.

4. Legal Basis for Processing

- Legitimate Interest: To operate, maintain, and improve the App.
- Legal Obligation: To comply with applicable laws.

- Consent: If you enable any optional analytics or personalization features (none enabled by default).

5. Purposes of Processing

- Provide and maintain App functionality;
 - Improve performance, stability, and features;
 - Diagnose and resolve technical issues;
 - Analyze usage to enhance user experience.

6. Data Retention

Data is retained only as long as needed for these purposes or as required by law. Device identifiers and usage logs are deleted or anonymized after 12 months.

7. Data Sharing & Disclosure

We do not sell, trade, or rent personal data. Data may be shared only with:

- Service Providers: Under confidentiality agreements.
 - Legal Authorities: In response to lawful requests.
 - Business Transfers: With confidentiality safeguards in mergers or asset sales.

8. International Transfers

Data may be processed outside your country. We implement safeguards, such as Standard Contractual Clauses, for cross-border transfers.

9. Your Rights

10. Children's Privacy

11. App Tracking Transparency (ATT) Compliance

If the App uses any tools that track activity across apps or websites, we comply with Apple's ATT framework. You will be prompted for permission before any tracking, and you can manage this at Settings > Privacy > Tracking on your device.

We use industry-standard measures (encryption, secure servers) to protect data. No system is fully secure; use the App at your own risk.
