

Terms and Conditions

1. The Gift Offer

- 1.1. This Gift Offer ("**Gift Offer**") is made by Pepperstone Markets Limited (company number: 177174B)("**Pepperstone**, 'we', 'us' or 'our").
- 1.2. For you to receive the Gift, you must comply with these Terms and Conditions and meet the **Eligibility Criteria**" set out in Clause 2 and Clause 3 **Deposit and Trade Requirements** ("**Criteria**").
