

# **TERMS AND CONDITIONS - 10% REBATE PROMOTION**

Some of the words in these Terms have special meanings:

**Client Agreement** means the applicable terms and conditions and associated documents that govern your account with us.

IB means Introducing Broker.

**Promotion** means this 10% rebate promotion.

Rebate means 10% of our minimum spread, or if you are trading FX with our Razoar account then 10% of our commission, based on the volume of trades that you make.

Terms means these Terms and Conditions.

"We" "us" or "our" means Pepperstone Markets Limited, Company registration number 177174 B | License number SIA-F217, of Sea Sky Lane, B201, Sandyport, Nassau, New Providence, The Bahamas.

# 1. Eligibility
