General

The Pepperstone Platform allows you to trade over the counter derivatives (**OTC-derivatives**) with Pepperstone Markets Limited (company number 177174 B) (**Pepperstone/us/our**) on compatible devices, over the internet or through an App (**Platform**).

You must be at least 18 years of age to use the Platform to trade with us. These Platform Terms and Conditions (**PTS**) apply to your use of the Platform and with our Client Terms and Conditions (**CTS**) (together the **Agreements**) govern the relationship between you and Pepperstone.

By downloading and/or accessing the Platform, you confirm you have read, understand and agree to be bound by the Agreements. In the event of any inconsistency between the PTS and CTS, the PTS prevails as it relates to your use of the Platform. We will update you, where required, if changes are made to the Agreements.

Your use of the Platform

All rights in the Platform, information, images and data you experience (together **Platform materials**) whilst using the Platform is owned and remains the property of Pepperstone (or its licensors, as applicable) at all times. You are granted a personal, non-exclusive, revocable and non-transferable right to access the Platform on your device to trade OTC-derivatives with Pepperstone (**Purpose**).

You will not, in relation to the Platform materials: (i) copy, rent, sell, lease, sublicense, distribute, assign, publish, display, change or otherwise transfer or encumber rights; (ii) make available to a third party; (iii) use in violation of the Purpose and/or any applicable laws and regulations; (iv) process, send or store prohibited information, infringing or unlawful material, viruses, worms, time bombs, Trojan horses or other harmful or malicious code, files, scripts, agents or programs; (v) circumvent or disable any digital rights management, usage rules, or other security features; or (vi) otherwise attempt to gain unauthorised access to, or disrupt the integrity or performance of such.

You acknowledge and agree that you are not a prohibited or restricted party by any government or located in a region that is the subject of any embargo, sanction or otherwise listed as a terrorist support region.

You should not allow anyone else to use the Platform and/or pretend to be you, on any device, whether through sharing account login details, family sharing or other similar means. If you are or wish to use a Trading Agent, please contact us to ensure the appropriate authority is provided. You are entirely responsible for the use of Platform on your device(s), the security of your device(s) and all login details. You must contact Pepperstone should you lose or have your device(s) or login details compromised or stolen.

We provide you with general data and information obtained from sources believed to be reliable but is not necessarily all-inclusive and is not guaranteed as accurate. We do not provide personal financial advice. You remain solely responsible for evaluating all information and deciding whether and how you use the Platform. We may also collect data regarding how you and your device interacts with the Platform, internet, communication networks etc. to assist with continual development and improvement of its operation and our services to you. In using the Platform, you agree to the collection and use of such data.
