

Terms and Conditions

In these Offer Terms:

“**Bonus**” means the amount payable to you if your client meets these Offer Terms;

“**Client**” means an individual or company who opened account, and meets the Deposit and Trade Requirements under these Offer Terms;

“**Offer**” means this “**Accelerate Your Journey**” Campaign, which is offered to you under these Offer Terms;

“**Pepperstone**”, “**we**” “**us**” or “**our**” means Pepperstone Markets Limited, IBC No. 177174, SIA-F217;

“**Pepperstone Pro**” means a Professional Client as defined in our Terms and Conditions of Service;

“**Promotion Period**” means on and from 17 February 2025 to 17 April 2025;

“**Terms**” means these terms;

“**Terms and Conditions of Service**” means the applicable terms and conditions and associated documents that govern your account with us; and

“**You**” “**your**” or “**yours**” means you, if you meet the criteria of an Eligible Client under clause 3 of these Offer Terms.

1 The Bonus

For you to receive your Bonus:

1.1 You must comply with these Offer Terms; and

1.2 You must:
