

# Terms and Conditions

## In these Offer Terms:

**“Bonus”** means the amount payable to you if your client meets these Offer Terms;

**“Client”** means an individual or company who opened account, and meets the Deposit and Trade Requirements under these Offer Terms;

**“Offer”** means this **“Accelerate Your Journey” Campaign**, which is offered to you under these Offer Terms;

**“Pepperstone”, “we” “us” or “our”** means Pepperstone Markets Limited, IBC No. 177174, SIAF217;

**“Pepperstone Pro”** means a Professional Client as defined in our Terms and Conditions of Service;

**“Promotion Period”** means on and from 17 February 2025 to 30 April 2025;

**“Terms”** means these terms;

**“Terms and Conditions of Service”** means the applicable terms and conditions and associated documents that govern your account with us; and

**“You” “your” or “yours”** means you, if you meet the criteria of an Eligible Client under clause 3 of these Offer Terms.

## 1 The Bonus

For you to receive your Bonus:
