# Terms and Conditions

### In these Offer Terms:

"Bonus" means the amount payable to you if your client meets these Offer Terms;

**"Client"** means an individual or company who opened account, and meets the Deposit and Trade Requirements under these Offer Terms;

"Offer" means this "Accelerate Your Journey" Campaign, which is offered to you under these Offer Terms;

"Pepperstone", "we" "us" or "our" means Pepperstone Markets Limited, IBC No. 177174, SIAF217;

"Pepperstone Pro" means a Professional Client as defined in our Terms and Conditions of Service;

"Terms" means these terms;
