

Terms and Conditions

In these Offer Terms:

“Bonus” means the amount payable to you if your client meets these Offer Terms;

“Client” means an individual or company who opened account, and meets the Deposit and Trade Requirements under these Offer Terms;

“Offer” means this **“Accelerate Your Journey” Campaign**, which is offered to you under these Offer Terms;

“Pepperstone”, “we” “us” or “our” means Pepperstone Markets Limited, IBC No. 177174, SIAF217;

“Pepperstone Pro” means a Professional Client as defined in our Terms and Conditions of Service;

“Promotion Period” means on and from 17 February 2025 to 17 April 2025;

“Terms” means these terms;

“Terms and Conditions of Service” means the applicable terms and conditions and associated documents that govern your account with us; and

“You” “your” or “yours” means you, if you meet the criteria of an Eligible Client under clause 3 of these Offer Terms.

1 The Bonus
