

## In these Offer Terms:

**"Bonus"** means the amount payable to you if you meet these Terms;

**"Trade Requirements"** means the requirements set out in Clause 2 of these Terms;

**"Offer"** means this Bonus offer, which is offered to you under these Terms;

**"Pepperstone", "we" "us" or "our"** means Pepperstone Markets Limited, IBC No. 177174, SIA-F217;
