

RoHS Compliance Letter RoHS 合规性声明

Dear Supplier, 尊敬的供应商,

RoHS stands for Restriction of Hazardous Substances, also known as Directive 2002/95/EC. This standard represents a regulations group in Europe with the goal of restricting hazardous material usage in electric and electronic products to help the environment and protect workers. Materials banned by RoHS are known to pollute landfills and are dangerous in terms of occupational exposure during both manufacturing and recycling.

RoHS 全称是《关于限制在电子电气设备中使用某些有害成分的指令》,也称为指令2002/95/EC。该标准代表了欧洲的一个法规组织,旨在限制电气和电子产品中有害物质的使用,以保护环境和工人。RoHS 禁用的材料会污染垃圾填埋场,并且在制造和回收过程中都存在职业暴露危险。

In 2011 the original Directive 2002/95/EU was superseded with the recast RoHS Directive 2011/65/EU (known as RoHS 2). And on 4th June 2015, the EU commission published a new Directive (EU) 2015/863 (RoHS 3) to amend Annex II of the Directive 2011/65/EU and add four phthalates onto the list of restricted substances.

2011年,原指令 2002/95/EU 被重新制定的 RoHS 指令 2011/65/EU (称为 RoHS 2) 取代。 2015年6月4日,欧盟委员会颁布了一项新指令 (EU) 2015/863 (RoHS 3),修订了指令 2011/65/EU 的附加条款 II,在禁用物质清单中增加了四种邻苯二甲酸盐。

EU RoHS 3 specifies the maximum levels for the following 10 restricted substances from 22nd of July 2021

2021年7月22日起, 欧盟 RoHS 3 对以下 10 种禁用物质的最高限值进行了设定:

- Cadmium 镉 (Cd): < 100 ppm
- Lead 铅 (Pb): < 1000 ppm
- Mercury 汞 (Hg): < 1000 ppm
- Hexavalent Chromium 六价铬: (Cr VI) < 1000 ppm
- Polybrominated Biphenyls 多溴联苯(PBB): < 1000 ppm
- Polybrominated Diphenyl Ethers 多溴二苯醚(PBDE): < 1000 ppm
- Bis(2-Ethylhexyl) phthalate 邻苯二甲酸二(2-乙基己基) 酯(DEHP): < 1000 ppm
- Benzyl butyl phthalate 邻苯二甲酸丁苄酯(BBP): < 1000 ppm
- Dibutyl phthalate 邻苯二甲酸二丁酯(DBP): < 1000 ppm
- Diisobutyl phthalate 邻苯二甲酸二异丁酯(DIBP): < 1000 ppm
