

TERMS & CONDITIONS
Freeport Lisboa Fashion Outlet
/Vila do Conde Porto Fashion Outlet Le
Bonnet scarf – Fashion Club Members

1. Context

As part of the Fashion Club loyalty program, Freeport Leisure (Portugal), Sociedade Unipessoal, Lda., and Vioutlets Vila do Conde, Unipessoal, Lda. (“the **Promoters**”), operators of Freeport Lisboa Fashion Outlet and Vila do Conde Porto Fashion Outlet respectively (“the **Centres**”), are organising this promotional campaign, which comprises an offer of one Le Bonnet scarf to Fashion Club members. This promotion will take place in each Centre from 29 October to 12 November 2025 (inclusive), or while stocks last (limited to existing stock). This promotional campaign is governed by these Terms and Conditions and is subject to a minimum spend and number of purchases.

2. Participation Criteria

2.1. All individuals aged 18 years or over who are Fashion Club members and comply with these Terms and Conditions (hereinafter “the **Members**”) may participate in this promotion.

2.2. Members must:

- (i) Make purchases registered with the Fashion Club between 29 October and 12 November 2025 (inclusive) at participating Fashion Club stores;
- (ii) Make purchases from three different fashion brands participating in the Fashion Club Programme, with a total minimum combined spend of €250 on the same day (all receipts must bear the same date);
- (iii) Purchases at food retailers (Lindt and/or Haribo) do not count towards the three-brand requirement but do count

towards the total accumulated spend of €250 (two hundred and fifty euros);

- (iv) Purchases in cafés and restaurants are excluded;
- (v) All purchases must be registered with participating Fashion Club brands. Registration may be made using either the Fashion Club card or app, provided both belong to the same Fashion Club account.
- (vi) Only one participation per Fashion Club account is permitted.

3. Le Bonnet Scarf Gift

- 3.1. Upon meeting the above criteria referred to in clause 2.2, the Fashion Club member will receive one (1) Le Bonnet scarf, in the colours available at the time, as this promotion is subject to existing stock.
- 3.2. The gift cannot be exchanged for cash.

4. Redemption Procedure

- 4.1. The Le Bonnet scarf can be collected from the Information Desk at either Freeport Lisboa Fashion Outlet or Vila do Conde Porto Fashion Outlet.
- 4.2. All receipts for qualifying purchases must be presented for validation at the Centre’s Information Desk during the promotional period. After this date, the promotion will no longer be valid and the gift cannot be claimed.
- 4.3. All receipts must be stamped and kept for further verification by the Information Desk team.
- 4.4. Only original receipts are accepted – duplicates, till slips, table checks or order notes are not valid.
- 4.5. Receipts for the purchase of gift cards, or those from cafés, restaurants or



food/beverage kiosks, as well as lottery or gaming purchases, will not be accepted.

5. Exclusion from Participation

- 5.1. Any failure to comply with these Terms and Conditions may result in exclusion from the promotion and refusal of the gift.
- 5.2. The following entries will also be excluded without prior notice:
 - (i) Use of false, altered, inaccurate or incomplete registration data;
 - (ii) Manipulation, modification or suppression of data or software linked to the promotion with the intent to influence it unfairly;
 - (iii) Use of software or technical devices (commonly known as “hacking” or “cheating”);
 - (iv) Multiple participations by the same individual, even if using different registration data.

6. Member Declarations

By participating in this promotion, each Member declares that:

- (a) Their participation has not been manipulated in any way;
- (b) Their participation is not linked to any payment or benefit, nor have they received or expect to receive any payment, advantage or compensation other than the opportunity to obtain the gifts described herein

or for promotional use by the Via Outlets Group.

7. Internet Use

- 7.1. Participation in this promotion implies awareness and acceptance of the characteristics and limitations of the Internet, including technical performance, risks of interruption, data protection limitations and potential virus infections.
- 7.2. The Promoter cannot, under any circumstances, be held liable for:
 - (a) Internet transmission errors;
 - (b) Malfunction of Internet connections and/or *software*;
 - (c) Consequences of viruses, bugs or technical defects;
 - (d) Any hardware or software malfunction.

8. Liability

- 8.1. The Promoter shall not be liable for any direct or indirect damages arising from interruptions, malfunctions, participant exclusions or cancellation of the promotion for any reason. This also applies to any damages related to the use of the *Website*.
- 8.2. The Promoter shall not be responsible for: (i) prizes not redeemed, (ii) any damage or loss incurred during the use of the prize.
- 8.3. The Promoter shall not be held liable for any cancellation or delay in the prize redemption caused by the participant, whether directly or indirectly.
- 8.4. Each participant must take all necessary measures to protect their data, devices and/or *software* on their computers

(including *tablets*) and/or mobile devices and/or their *website* against any cyberattack.

- 8.5. Connection to the Promoter's *website* and participation in this promotional campaign are the sole responsibility of the Participants. The Promoter shall not be held liable if this promotion is modified, interrupted or cancelled due to events of force majeure or for reasons beyond its control.

During this promotion, the Promoter may publish additional rules or amendments in cases of force majeure, following notification. Any such amendments shall be deemed to form part of these Terms and Conditions.

- 10.1. The Promoter reserves the right to alter, extend or permanently cancel the promotion in situations or events beyond its control, with no right to compensation for participants. The Promoter shall not be held responsible if the promotion is interrupted, delayed or cancelled for reasons beyond its control.

- 10.2. Any cases not expressly covered in these Terms and Conditions shall be decided by the Promoter, whose decision is final.

11. Acceptance of Terms & Conditions

Participation in this promotion implies full and unconditional acceptance of these Terms and Conditions.
