Lettings FAQs everything you need to know

How much could I earn?

Earnings vary based on your park, holiday home size, and letting frequency. Speak to our Holiday Services Manager for a personalised estimate.

Which breaks earn the most?

Peak periods, such as school holidays and bank holidays, typically generate the highest income.

Can I still change my letting dates?

Yes, depending on bookings already confirmed in your holiday home. Simply email lettings@parkholidays.com at least 2 weeks in advance to request an amendment to your dates.

How do I access my letting income?

All earnings are credited to your Owner's Account. You can transfer funds to your bank at any time.

When will I be paid?

Payments are made between 2-4 weeks after guest departure.

Can I track my earnings?

Yes, you will receive weekly booking updates and an annual statement.
