FUND OBJECTIVE

The fund aims to achieve long-term inflation-beating growth from a cost-efficient balanced portfolio with an equity exposure typically displayed by multi-asset medium equity portfolios conforming to the regulations governing retirement fund investments.

WHO IS THIS FUND FOR?

This fund is suited to investors wanting moderate long-term growth in a cost-efficient multi-asset medium equity fund with less volatility in the short term compared to a pure equity fund. The fund is suitable as a stand-alone retirement investment.

INVESTMENT MANDATE

The fund is exposed to all sectors of the market (shares, bonds, property and cash) with a maximum of 60% exposure to equities and may gain exposure to foreign assets up to a maximum of 30% of its portfolio (with an additional 10% for African ex-SA investments). The fund will have a minimum exposure of 50% to passively managed underlying securities. Derivatives may be used for efficient portfolio management purposes.

REGULATION 28 COMPLIANCE

The fund complies with retirement fund legislation. It is therefore suitable as a stand-alone fund in retirement products where Regulation 28 compliance is specifically required.

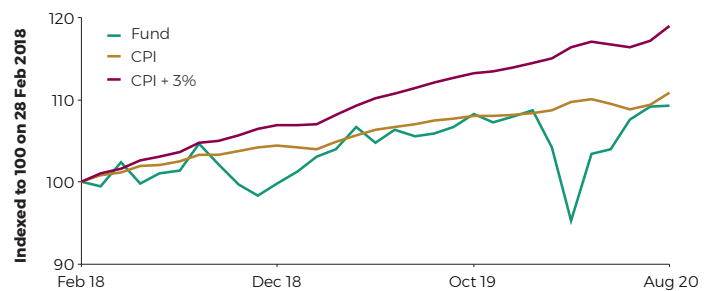

FUND COMMENTARY AS AT 30/06/2020

The broad South African equity market exposure in the fund is primarily through an allocation to the FTSE/JSE Capped Shareholder Weighted Index (Capped SWIX), which is intended to be a fairer reflection of the investment universe available to a South African investor. The Capped SWIX has a strategic weighting of 35% in the fund and returned 21.6% for the quarter ending August 2020.

The best performing sector was basic materials with a return of 41.3% for the quarter. Consumer services was the worst performing sector for the quarter, returning 5.0%.

In addition to the broad local equity market exposure, the fund also has exposure to SA listed property with a strategic weighting of 7.5%. The JSE SA Listed Property Index returned 20.4% for the quarter ending August 2020.

The international equity exposure is invested in the MSCI All Country World ESG Leaders Index, which has a strategic weighting of 15.0%. The MSCI All Country World ESG Leaders Index offers exposure

to both developed and emerging markets globally. The MSCI All Country World ESG Leaders Index returned 18.9% in USD terms for the quarter. The rand strengthened by 2.8% against the US dollar over the quarter, which would have a negative impact on returns to South African investors.

To diversify the fund away from equity, it invests in nominal bonds through exposure to the JSE All Bond Index (ALBI), which has a strategic weighting of 15.0%. The JSE ALBI increased by 9.9% for the quarter. The middle of the duration curve was the best performing, returning 13.2%, while the short duration bonds returned 6.3%.

In addition to the nominal bond exposure, an allocation is also made to inflation-linked government bonds through exposure to the JSE IGOV Index, which has a strategic weighting of 10.0%. The JSE IGOV Index increased by 10.0% for the quarter.

INITIAL CHARGES (Incl. VAT)*:

There is no initial administration charge for investment transactions of R500 and above. Initial adviser fee will be between 0% and 3.45%. Investment transactions below the R500 fund minimum incur a 2.30% administration charge.

EXIT FEE:

Old Mutual Unit Trusts will charge an exit fee of 2.30% if exiting within 2 weeks of entry and reserves the right to charge this fee if exiting within 6 months of entry. The exit fee will not apply to investments in the fund via the Old Mutual Unit Trusts Tax-Free Investment.

Other charges incurred by the fund, and deducted from its portfolio, include audit, custodian and trustee charges and service fees of collective investment schemes in which the fund holds interests. These are included in the TER.
