FUND OBJECTIVE

The fund aims to offer superior returns over the medium to longer term by investing in companies with a market capitalisation smaller than the company with the lowest market capitalisation listed on the FTSE/JSE Large Cap Index (J205).

WHO IS THIS FUND FOR?

This fund is suited to investors seeking long-term capital growth by investing in a focused portfolio of mid- and small cap companies. These investors can tolerate stock market volatility.

INVESTMENT MANDATE

The fund invests in established companies with a market capitalisation smaller than the company with the lowest market capitalisation listed on the FTSE/JSE Large Cap Index (J205). The fund aims to achieve its performance objectives through superior share selection. Derivatives may be used for efficient portfolio management purposes.

REGULATION 28 COMPLIANCE

The fund aims to achieve long-term inflation-beating growth, and may hold a higher allocation to equities and a greater exposure to a single equity than what is allowed in terms of Regulation 28 of the Pension Funds Act. This fund is therefore not Regulation 28 compliant.





FUND COMMENTARY

In the midst of the booming start to 2020, news began filtering in about a flu-like virus that was spreading rapidly in the Chinese city of Wuhan. In the following weeks, the virus was spreading at an exponential rate, negatively affecting the global economy. In the first quarter of 2020, we saw the fastest market crash in memory, with central banks responding with the largest dose of stimulus in history.

In an extraordinary reversal of the previous quarter, alongside global markets, SA has rebounded from one of the fastest crashes of all time, delivering one of the fastest recoveries of all time. The small cap and mid-cap indices ended the quarter up, returning

18.6% and 15.7% respectively in the quarter ending 30 June 2020. The rand US dollar exchange rate also ended the quarter slightly stronger, with the rand gaining 3% against the dollar.

The quarter also brought the release of the Supplementary Budget in June, forecasting a deficit of 15.7%. The South African Reserve Bank brought some relief to consumers by cutting rates by 275 basis points this year, taking the repo rate down to 3.75%, the lowest level since the 1970s.

We are bullish on the gold price in the medium term, given the ongoing uncertainty and unprecedented levels of liquidity created by central banks in an attempt to stave off the crisis. The platinum group metals (PGMs) price basket surged in response to Covid-19-related closures of South African mines. Our holdings in AngloGold Ashanti and Impala Platinum made a positive contribution to performance in this quarter.

Our SA Inc exposure has delivered mixed results this quarter, as cyclical counters such as Raubex

Group and Transaction Capital rebounded strongly while defensive holdings such as Dis-Chem and Rhodes Food Group lagged.

As we continue to see social distancing and lockdown policies implemented globally in a bid to flatten the curve, we have positioned our portfolios towards more defensive stocks. The importance of robust business models, strong balance sheets with low leverage and prudent capital allocation is elevated in times of crisis. We are yet to see the full impact of Covid-19 (and the resultant lockdown) on company profits, balance sheets and cash flows.

We believe that the current uncertainty and collapse in the valuations of what were already attractively valued South African assets, afford us the very rare and unique opportunity to invest in great businesses at these low levels, in line with our objective to grow our clients' wealth over the long term.
